East Bay CREW Most Valuable Member (MVM) Award

This annual award is designed to promote the benefits of networking within East Bay CREW, to recognize and reward member(s) for working together and to document transactions of the chapter among its members. The MVM promotion for 2010 will run from September, 2009 to August 2010. Winners will be announced at the August luncheon. Five awards will be given:

Most Valuable Member (MVM) Award – One (1) CREW Network Convention registration to an eligible East Bay CREW member who has accumulated the most number of points – VALUE \$700

Valuable Member (VM) Award – One (1) CREW Network Convention registration to be raffled at large to the top 25% of all eligible East Bay CREW members (as determined by the number of points accumulated) – VALUE \$700

Special Member (SM) Award - Three (3) free registrations to the East Bay CREW Signature Event Reception will be raffled off to all East Bay CREW members who qualify for this promotion by submitting at least one referral – Value \$100 each.

Qualifying Transactions equal to (2) points =

- CREW Member refers a deal to another CREW Member; Deal must close in the period that the referral credit is taken.
- CREW Member refers a prospective CREW Member to EB CREW; Prospect needs to become a member in the period that the referral credit is taken. Credit will be split between the two CREW Members who sponsor the Member into CREW
- CREW Member refers a prospective Sponsor to EB CREW; Prospect needs to be a Sponsor in the period that the referral credit is taken
- CREW Member is a volunteer in a committee; Member needs to be a committee member for at least seven (7) months in the period that the referral credit is taken. If a new member, he/she has to have been a member of a committee for at least 3 months.

Qualifying Transactions equal to (1) point =

- Partial credit (1/2 credit) is given if a written quote or a Letter of Intent is provided but not accepted.
- Partial credit (1/2 credit) is given for any other activity attempted in good faith to promote business within the chapter subject to the Award Moderator's approval.

Disclaimer: *Points are valid as long as the transaction or referral involves at least one paid eligible East Bay CREW member. All points must be approved by the Award Moderator.*
